MTIC (MASTERS OF LAW IN TRADE, INVESTMENT AND COMPETITION LAW & POLICY)

The MTIC is a ground breaking, nine-month modular executive-format Masters of Law program (with a maximum candidature of two years) in the field of international trade, investment and competition law & policy.

Jointly developed with the World Trade Institute (WTI) at the University of Berne, Switzerland, and the generous support of the Swiss State Secretariat for Economic Affairs (SECO), the MTIC is taught by a global team of distinguished faculty, experienced professionals and legal experts.

Each course is taught over one-week, comprising 4 sessions of 4 hours each. Typically, a course is taught over 4 days—Monday through Thursday—with classes running from 5:30-9:30 pm. Classes will be held at the centrally located UPH Graduate Campus, Plaza Semanggi, in the heart of Jakarta's Central Business District (CBD).

The MTIC is engineered to enhance students' knowledge, skill and mindset, and help them serve the growing global demands in today's competitive global economic landscape. The program focuses on trade, investment and competition, the three pillars of regional economic integration.

PROGRAM STRUCTURE

The MTIC is comprised of legal foundational courses, the MTIC core and Law Electives. Students are required to complete a total of 40 credits before graduation.

Students without a prior law degree are required to enroll in a legal matriculation class. Alternatively, a Professional Certification does not require a prior law degree (see next section for more information).

PTIC (PROFESSIONAL CERTIFICATION IN TRADE, INVESTMENT AND COMPETITION LAW & POLICY)

The PTIC is an exclusive, three-month modular Professional Certification program in the field of trade, investment and competition law and policy jointly awarded by the World Trade Institute at the University of Berne, Switzerland and UPH Faculty of Law.

The PTIC is taught by a global team of distinguished faculty, experienced professionals and legal experts.

Each course is taught over one-week, comprising 4 sessions of 4 hours each. Typically, a course is taught over 4 days—Monday through Thursday—with classes running from 5:30-9:30pm. Classes will be held at the centrally located UPH Graduate Campus, Plaza Semanggi, in the heart of Jakarta's Central Business District (CBD).

A prior degree or background in law is not required for students enrolling in the PTIC program.

The PTIC program runs from January to April, and students will complete Module II of the MTIC Program, which comprises the following courses:

The PTIC is engineered to enhance students' knowledge, skill and mindset in key areas of international economic diplomacy and global governance, and to help them understand the growing complexity and practice of trade, investment and competition law and policy.

Our modular curriculum allows PTIC graduates to work towards a Masters of Law with an additional six months of study:





CERTIFICATE OF COMPLETION (CoC) FOR INDIVIDUAL MTIC MODULES

All courses under UPH Faculty of Law's trade, investment and competition law and policy program are available to external, non-degree participants on an individual course basis. Students who have successfully completed the courses will be awarded a Certificate of Completion (CoC).

A background in law is not required for students pursuing a CoC.

Each course is taught over one week, comprising 4 sessions of 4 hours each. Typically, a course is taught over 4 days—Monday through Thursday—with classes running from 5:30-9:30pm. Classes will be held at the centrally located UPH Graduate Campus, Plaza Semanggi, in the heart of Jakarta's Central Business District (CBD).

In partnership with the World Trade Institute at the University of Berne, Switzerland, the MTIC Core is taught by a global team of distinguished faculty, experienced professionals, and legal experts.

Students with CoCs who subsequently decide to enroll in the Professional Certificate (PTIC) or Masters of Law (MTIC) programs can earn credits for the courses that they have completed.

ADMISSIONS ELIGIBILITY

Our students come from a variety of professional backgrounds, whether it be practicing lawyers, government officials, academics, consultants, or recent college graduates who have exhibited a strong academic record.

A legal background is not required for students enrolling in the PTIC and CoC programs.

A prior law degree is required for students pursuing the MTIC degree. Students without a prior law degree will be required to take a legal matriculation class.

ENGLISH LANGUAGE PROFICIENCY

A minimum TOEFL score of 500 is recommended. Waivers will be given on a case-by-case basis for students with relevant work experience or other qualifications implying English proficiency.

Course Description

LAW OF THE WTO

This course covers the liberalization of trade in goods (GATT) and services (GATS). Non-discrimination principle is a core principle of the international trading system, and a detailed understanding of its meaning in international trade law will be of particular interest to all interested in WTO law, including government, NGOs, international lawyers and academics. The course involves an in-depth introduction into the scope and contents of the GATT and GATS and its key legal principles and obligations with a special focus on the relevant case law.

ECONOMIC ANALYSIS OF LAW

This course addresses the theoretical underpinning of international law. Why do nations comply with international law at all? Though some attention is given to traditional legal thought on the subject, for the most part, the course adopts a law and economics approach to the question, treating states as rational actors. This course will explore why international agreements look as they do, how states choose between hard and soft law (among other things), and the role played by international tribunals. The theoretical approach will be complemented with selected inquiries into the rules and practices of the WTO.

DISPUTE SETTLEMENT

This course aims to introduce students to the basic principles, institutions, and proceedings of the WTO dispute settlement system as well as on WTO dispute settlement practice to date. Case law relating to jurisdiction of and access to the system and rules of interpretation and burden of proof is extensively discussed. Also the rules of conduct, the remedies for breach of WTO law and the special rules and assistance for developing-country members are dealt with in detail.

TRADE REMEDIES

This course examines the provisions of the WTO Agreement on Subsidies and Countervailing Measures, their implementation and evolution. The course covers both substantive and procedural aspects from a practical perspective from government, industry, practicing lawyers and NGOs interested in development issues.

Legal and practical questions will be raised during the course, where appropriate with examples of dispute settlement cases.

NON TARIFF MEASURES (NTMS)

This course focuses on non tariff measures i.e tariffs, tariff restrictions, voluntary export restraints (VERs), tariff rate quotas and licensing regimes, the law of quantitative restrictions (methods, concessions, consolidation, bindings, compensation) of particular interest to private sector trading, agriculture and government negotiations and regulation.

INVESTMENT LAW

This course covers the economic principles behind international investment activities in the global economy and the role and implications of WTO law (TRIPs, GATS) for investment. Analysis of multilateral and bilateral rules on international investment, in particular with regard to investment protection and promotion in bilateral investment treaties (BITs) and at the multilateral level. A particular emphasis lies on problems related to investment arbitration and its implications for the development of rules and procedures in this field.

COMPETITION LAW

The course focuses on restrictive business practices of an international scope and how they may be addressed by trade and competition rules. It includes a detailed discussion of failures of the current multilateral trading system to address international competition law problems, options to regulate competition law in the WTO and through other means, and a review of international case law in the grea.

ASEAN AND GLOBAL ECONOMIC GOVERNANCE

This course focuses on regional integration and the manner in which it is related to the disciplines of WTO law by adopting both an economic and a legal perspective. On the economic side, the course will cover the basic economics of preferential agreements, including the political economy of why countries join RTAs, the core ideas of trade creation and trade diversion, and the impact on competition and growth. This course is of interest to trade policy officials dealing with bilateral and regional

relations as well as practitioners confronted with preferential trade issues.

THE PRACTICE OF TRADE AND INVESTMENT NEGOTIATIONS

The course focuses on practical aspects of trade and investment negotiations. It will look at the challenges for national economic, trade and investment policy in the context of the globalized economy and discuss benefits and costs of trade and investment liberalization as well as the international regulatory framework. Against this background, the main elements of the negotiation process are presented and discussed, including stakeholders, organization and stages of the negotiation process, as well as fundamental negotiating skills. Teaching methods include lecture, group discussions, analysis of Trade Agreement texts and a simulation exercise

ROLE OF LAW IN ECONOMIC DEVELOPMENT

This course will address the key policy linkage between trade and development. It will begin by exploring the key legal and economic issues arising from the enlarged role and voice of developing countries in trade governance. From there it will explore linkages between trade, growth and development, address issues of distributive fairness in trade rulemaking, and highlight some of the concerns that developing countries have with the special and differential provisions in the WTO and the current status of the work programs in this reaard.

ECONOMICS OF INTERNATIONAL TRADE

The lecture will introduce the students to the sweeping process of globalization and to its regulatory implications. Painting the big picture of globalization of firms, markets and regulation, it will focus on the latter and in particular on international economic law. Building upon regulatory theories, the lecture will illustrate the changes in regulatory design at all levels of governance, as globalization deepens and affects not only the economy but all facets of societal life.

AGRICULTURE AND FOOD SECURITY

This course explores the WTO Agreement on Agriculture and its application and implementation since its inception. Presents an overview of the trade and income implications of liberalizing agricultural trade in order to understand who might gain and who might lose from more open agricultural markets. Includes other issues also affecting international agriculture policies, such as sanitary and technical regulations and private standards, climate change, biofuels, water shortage, demography and the WTO impact on food security.

INTELLECTUAL PROPERTY RIGHTS

This course explores the general rules of the TRIPS Agreement as well as its negotiating history and interpretation up to the present. It offers an introduction into the main economic principles surrounding the protection of intellectual property. This course also focuses on the international rules applicable to industrial property and the specifics of this sub-field of intellectual property rights. Finally it gives an introduction to the World Intellectual Property Organization (WIPO), its relationship to the WTO and its rules on intellectual property, as well as the registration and enforcement of intellectual property rights.

TRADE FACILITATION

The course covers the many challenges of managing the border, drawing attention to the economics of trade costs and the economic underpinnings of the recent trade policy interest in issues of trade facilitation. The course also reviews the key legal and negotiating challenges arising in customs law, explores the complex area of rules of origin in both multilateral and preferential negotiation settings and concludes with an in-depth look at the negotiation agenda on trade facilitation in the WTO.

TRADE, ENVIRONMENT AND CLIMATE CHANGE

This course will tackle a range of issues of sustainable development and protection and preservation of the environment, including recent developments in international environmental law. The course explores domestic and international measures used to reduce greenhouse gas emissions and their interaction with the multilateral trading system. It also examines the ways in which the WTO contributes to environmental protection and preservation through its various bodies, while also looking at the legal interaction between trade law and multilateral environmental agreements

TRADE POLICY FORMULATION

This course explores on the mechanics of trade policy formulation and its implementation in some countries. Trade policy formulation is best understood by considering it in several contexts: constitutional, legal, institutional, and political. It is also important to understand the way in which various players in the trade policy process interact with one another and with key stakeholders in the public, private and NGO spheres. This course also provides an introduction to the complex legal and institutional framework for the trade policy process, examines key tools available for influencing and implementing trade policy, and explores some strategic and political dimensions of the process.

INTERNATIONAL TRADE AND INVESTMENT ARBITRATION

This course provides an introduction to international arbitration in the areas of international trade and investment. The approach will be one from a practical perspective. Students will be expected to review international treatises, statutes and case law on the subject. The course will comprise five main topics: (1) an introduction to international arbitration; (2) the agreement to arbitrate; (3) the arbitral tribunal; (4) the arbitral process; and (5) the recognition and enforcement of the arbitral award.
